**Do you expect the Supreme Court will revisit the gay marriage decision from 2015 if a case challenging gay marriage reaches its review? Should it?**

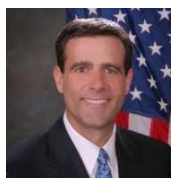

**Highlight of Current Civic Involvement/Accomplishments:**

I'm proud to have a voting record as a member of Congress that reflects the priorities of the constituents I represent. Serving on the Homeland Security Committee and Judiciary Committee give me an opportunity to lead on the important issues of border security, illegal immigration, and defending the Constitution. These are all areas where I have previous subject matter expertise as a U.S. Attorney and federal terrorism prosecutor, and I believe my existing familiarity with the issues these committees have jurisdiction over has allowed me to dive in and make an immediate impact.

Specifically, I feel fortunate to have been given the opportunity to chair the Cybersecurity Subcommittee on the Homeland Security Committee. As we've seen from an ongoing string of cyber-attacks against private industry and the federal-government, cybersecurity is national security, and my previous experience prosecuting cyber-crime has enabled me to use this subcommittee chairmanship to advance meaningful legislation. I'm proud that my bill, the Strengthening State and Local Cyber Crime Fighting Act of 2017 was signed into law by President Trump.

I've had 20 bills and amendments pass the House during my two terms in Congress, with two of them being signed into law. My work legislatively to restore sanity to the government regulatory process and prevent overreach by Federal agencies in areas such as our agricultural, manufacturing, and economy from their original congressional intent has been a focus and will continue to be.

Most of all, I take pride in being an accessible and transparent member of Congress, and enjoy engaging with constituents all across the 18 counties I represent. By participating in community events, and speaking to civic groups, I feel I am able to do my job better as the representative for more than 700,000 Texans.

I served for eight years as the unpaid, non-partisan mayor of Heath, Texas. Over that eight-year period, Heath was the only municipality in Rockwall County not to raise taxes. Because we were able to balance budgets throughout the worst economic recession in 70 years without raising taxes, the city's credit rating was raised by all three of the nation's leading credit agencies.

I have also previously served as a board member of the Rockwall ISD Educational Foundation, the Rockwall County YMCA, and on the Advisory Board of Texas A&M's Engineering Extension Service (TEEX), the largest emergency response and homeland security training facility in the world.

**Why are you running for office?**

I spent my first term in Congress as a leading conservative voice to combat the failed policies of the Obama Administration. This past year, I have been working with President Trump and Republican majorities in Congress to restore the promise of this great country. Together, we have worked to reduce the regulatory burden imposed on American families and businesses, strengthen our military, and deliver a once-in-a-generation tax reform for the American people. Specifically, legislation to prevent the federal government from intruding on individuals' right of conscience, as well as legislation to safeguard churches, businesses, and organizations from being denied tax-exemptions, contracts, licenses, and certifications for adhering to traditional marriage views. I will continue to support measures that protect Americans' religious liberty that is guaranteed in the 1st Amendment.
